Executive Summary

The first mission, which lasted 2.5 days, focused primarily on assessing available data sources in Bosnia and Herzegovina. The consultants presented practices from their countries in the field of construction statistics and ongoing efforts in developing new Commercial Real Estate Indicators (CREI). Subsequently, the participants from the BiH statistical institutions: Agency for Statistics of Bosnia and Herzegovina (BHAS), the Institute of Statistics in the Federation of Bosnia and Herzegovina (FIS) and the Republika Srpska Institute of Statistics (RSIS) presented their processes for producing statistics on building permits and the information they obtained from various sources related to the CRE indicators. Potential sources were identified for tracking construction starts and works completion. Initial information suggests that BiH municipalities may possess relevant data.

During the meeting, it was agreed that all the three BiH institutions will organise a meeting with municipalities' representatives in the coming months. The consultants also drafted a letter for contacting municipalities in order to provide necessary information for the meeting. As preparation for the next mission, the three statistical institutions should conduct an analysis of building permits data for the past 5 years. Information gathered from both these recommendations should be presented during the next mission, which is scheduled for the last week of January 2025.

1. General comments

This Mission Report was prepared within the EU Twinning Project "Further Development of the Statistics System in Bosnia and Herzegovina". It was the first mission to be devoted to the Commercial Real Estate Indicators (CREI) Subcomponent of the Project.

The purposes of the mission were:

- Assessment of available data sources, creation of new survey/extension of currently used survey, compilation of CREI variables
- Initiation of discussion of methodology to be applied
- Writing Mission Report
- Preparation of ToR for next mission

The consultants would like to express their gratitude to all officials and individuals from Bosnia and Herzegovina met for the kind support and valuable information, and which highly facilitated the work of the consultant.

2. Assessment and results

At the beginning of the meeting, the Resident Twinning Adviser (RTA) outlined the main objectives of this first mission. The MS experts from Slovenia and Italy presented available information on the current state of the new EU Regulation proposal on Commercial Real Estate Indicators (CREI). They also shared current practice regarding the production of statistics on building permits and activities related to new CRE indicators. In Slovenia, the plan is to utilize the same administrative sources as for building permits.













Continuing on, the BiH participants presented their current processes for producing statistics on building permits and the information they have obtained from different sources regarding construction starts and works completion. During the mission, it was concluded that these laws could potentially cover the new requirements concerning two new indicators (construction start and works completion). The current situation in BiH is that the investor is required to inform the responsible municipality about the start and the completion of construction works using a prescribed form. Based on these information, the conclusion was that municipalities should possess the required information for the production of the two new CRE variables. It was agreed that before initiating a new survey, the responsible persons of the three statistical institutions in BiH should organise a meeting with some BiH municipalities to gather additional information on the responsible persons within the municipalities in charge of these activities and on their processes of collecting relevant data. For this purpose, the consultants prepared a draft letter, which can be used to approach the municipalities. As for now, no potential sources for vacancy rates have been identified and it has been decided that the twinning project will focus only on the two variables: construction start and works completion. Vacancy rates is currently not foreseen to be part of the EU regulation.

Based on the information and proposal of Eurostat's Task Force for CRE indicators, and considering that in BiH there already exists a survey on building permits, the consultants suggested that it would be beneficial to analyse those data to understand what portion represents relevant data for commercial real estate and their share using Classification of types of construction (CC classification). The representatives of all the three statistical institutions of BiH agreed to carry out this task before the next mission.

3. Conclusions and recommendations

Initial information suggests that municipalities likely already possess the relevant data. It is necessary to determine how to collaborate with them and analyze the format of this data. It was agreed that the representatives of all the three statistical institutions would organise a meeting with municipalities' representatives in the coming months.

Additionally, by the next mission, the three statistical institutions should conduct an analysis of building permit data for the last 5 years. Information gathered from both recommendations should be presented during the next mission.

It was also agreed that the representatives from some municipalities should be invited to a meeting during the next mission in order to gather some additional information from them.

Based on the results of analyses conducted by the three statistical institutions in BiH and the information they gathered from the municipalities, the next steps in creating a new survey will be further considered during the following mission. Since the regular monthly production of issued building permits data is already established, this survey could serve as a foundation for collecting data on construction start and works completion on a quarterly basis.
